AN ORDINANCE VACATING A PORTION OF KINLOCK STREET IN KLAMATH ADDITION TO THE CITY OF KLAMATH FALLS, OREGON; AND DECLARING AN EMERGENCY. Harold Derrah

WHEREAS, on September 16, 1968, pursuant to Resolution No. 1693, the Common Council of the City of Klamath Falls, Oregon, held a public hearing on a proposal to vacate a portion of Kinlock Street in Klamath Addition to the City of Klamath Falls, Oregon; and

WHEREAS, the Common Council of the City of Klamath Falls has determined that it is to the best interest of the City that said Street be vacated; therefore,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Section 1.

That portion of Kinlock Street described as follows:

Beginning at the point of intersection of the west line of Section 33, T38S, R9E, Willamette Base Meridian, with the southwesterly line of Sixth Street, 60' wide; thence S 55° 46'30"E along said southwesterly line 23.58 feet to its intersection with the southeasterly line of Kinlock Avenue as shown upon the original plat of the Klamath Addition to Linkville; thence S 38°56'W along said southeasterly line a distance of 115.72'; thence S 78°57'W, a distance of 54.45' to the southeasterly line of Block 106 of said Klamath Addition; thence northeasterly along said southeasterly line to the most easterly corner of said Block 106; thence southeasterly in a direct line to the point of beginning and containing 0.041 acres, more or less:

all in Klamath Addition to the City of Klamath Falls, Oregon, be, and the same is hereby vacated.

Section 2.

Time being of the essence, the immediate enactment of this ordinance is deemed necessary, an emergency is declared to exist, and this ordinance shall be in full force and effect from and after its passage and its approval by the Mayor.
