RIGHT-OF-WAY EASEMENT (Individual)

For value received the undersigned, hereinafter referred to as Grantors, (whether singular or plural), do hereby grant to PACIFIC POWER & LIGHT COMPANY, a corporation, its successors and assigns, the Grantee, an easement or right-of-way for an electric transmission and distribution line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph wires, towers, poles, props, guys, anchors and other supports and the right to place all or any part of such line underground) at or near the location and along the general course now located and staked out by the Grantee over, across and upon the following described real property in Klamath County. State of Oregon to wit:

A tract of land situated in the SW4SW4of Section 5 and the SE4SE4 of Section 6, Township 39 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a point on the Northerly right of way line of Arrant Road, said point bears North 040 44' 49" West 30.09 feet from the Southeast corner of said Section 6; thence North 25° 08' 57" East along the Westerly line of the existing 30 foot road easement, 440.00 feet; thence North 87° 12' 47" West 607.82 feet; thence South 02° 42' 43" East 430.00 feet to the Northerly right of way line of said Arrant Road; thence North 89° 45' 38" East 399.77 feet to the point of beginning of beginning.
