KNOW ALL MEN BY THESE PRESENTS, That DONALD W. MILTENBERGER, ORVILLE C. MILTENBERGER, AND GLENN H. MILTENBERGER, COMPOSING H. C. MILTENBERGER & SONS, a partnership hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by CECIL E. LAYMAN, hereinafter called AND BARBARA A. LAYMAN, husband and wife, the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

The Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$  NE $\frac{1}{4}$ ) of Section Thirteen (13), Township Twenty-three (23) South, Range Nine (9) EAST OF THE WILLAMETTE MERIDIAN.

SUBJECT TO easements of record, reservations in patent and established easements for roads, irrigation canals and ditches, and power and utility transmission lines.

SUBJECT TO Easement for transmission line, including the terms and provisions thereof, executed by Clarence V. Parsons and Lila F.
