An existing road in the East half of the Southeast quarter of the Northwest quarter (E $\frac{1}{2}$ SE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 9, Township 33 South, Range 7 East of the Willamette Meridian in Klamath County, Oregon, said road being located as shown in red on Exhibit "A" attached hereto and by this reference made a part hereof.

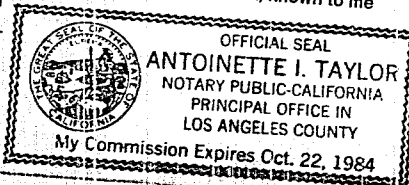

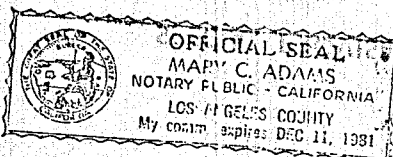

SPECIAL PROVISIONS

Licensees or permittees of Grantee, when using the roadway on said easement and right of way, shall maintain the said roadway in a condition as good as existed prior to the commencement of such use, provided that when said licensees or permittees and other authorized parties jointly use said roadway, then each party shall be responsible for a proportionate part of the entire maintenance which said part shall be based upon the ratio of party use to total use.
