8 A hearing was held in this matter at Klamath Falls, Oregon, on June 10, 1981, pursuant to notice given in conformity 91 10 with Ordinance No. 35, Klamath County, before the Klamath County 11 Assistant Hearings Officer, James R. Uerlings. The applicant was 12 present. The Klamath County Planning Department was represented 13 by Jonathan Chudnoff. The Hearings Reporter was Barbara Thomson.

14 Evidence was presented on behalf of the applicant and 15 on behalf of the Department. There were no adjacent property 16 owners present who stated they had objections to the proposed Conditional Use Permit requested by the applicant. 17

The site for the proposed use is adequate in size 2 and shape to accommodate said use and all yards, spaces, walls and fences, parking, loading, landscaping and other features 3 required to adjust said use with land and uses in the neighborhood 4 are present or will be adequately provided. 5

2. The site for the proposed use has adequate access 7 to streets and highways adequate in width and pavement type to carry the quantity and kind of traffic generated by the proposed 8 use, 9

10 The proposed use will have no adverse effect on 3. abutting property or the permitted uses thereof. 11 |
