WHEREAS, on September 19, 1977, pursuant to Resolution No. 2523, the Common Council of the City of Klamath Falls, Oregon, held a public hearing on a proposal to vacate that dedicated alley lying in the southerly portion of Block 6 of the Hot Springs Second Addition in the City of Klamath Falls, Oregon; and

MHEREAS, the Common Council received a recommendation from the Planning Commission, which conducted a public hearing on August 8, 1977, which recommended approval of the proposed vacation; and

WHEREAS, the Common Council of the City of Klamath Falls has determined that it is in the best interest of the City that said alley be vacated; therefore,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Section 1.

That dedicated alley lying in the southerly portion of Block 6 of the Hot Springs Second Addition be vacated.

Section 2.

A sum of \$2,200 shall be paid to the City, by the property owner adjacent to the vacated rights-of-way, in satisfaction of Section 42 of the City Charter.
