## LOAN AGREEMENT

THIS AGREEMENT made and entered into this 5th day of August, 1981, by and between LOCAL UNION #190, UNITED BROTHERHOOD OF CARPENTERS AND JOINERS OF AMERICA, hereinafter referred to as the first party, and LEROY DALE STENSENG and PATRICIA A. STENSENG, husband and wife, hereinafter referred to as the second party;

WHEREAS, the first party has undertaken to borrow the sum of \$6,000.00 from the second party, and has covenanted to pledge that certain Trust Deed recorded in Volume M78 at page 2930 as security herein for the above indebtedness;

THAT in the event of the deaths of either of the above second parties, that the spouse therein shall have the right of survivorship in the payment of the above loan;
