

CONSTRUCTION LIEN

KNOW ALL MEN BY THESE PRESENTS: The undersigned, hereinafter called the claimant, has performed labor upon, transported or furnished materials and/or rented equipment (as hereinafter described), actually used in the construction of that certain improvement known as DODDS HOLLOW SUBDIVISION, all at the instance of the owner of said improvement or his construction agent; said improvement is situated upon certain land in the County of Klamath, State of Oregon, (which is the site of said improvement) described as follows:

Township 40 South, Range 11 East of the Willamette Meridian:

Section 20: NE1/4 SE1/4
Section 21: NW1/4 SW1/4

Township 40 South, Range 11 East of the Willamette Meridian:

Section 20: E1/4 NE1/4; SE1/4 SE1/4
Section 21: W1/2 NW1/4

Section 29: SE1/4 NE1/4 lying Northerly of the County Road.

The address of said land is unknown.

The names of the owners or reputed owners of said land are Ben Culet, Robert C. Johnson and Patricia A. Johnson, doing business as Tara Enterprises, John Mason and Carolyn Mason, and Richard Killins and Julia Killins.

The names of the owners or reputed owners of said improvement are Ben Culet, and Robert C. Johnson and Patricia A. Johnson, doing business as Tara Enterprises; the persons just named at all times herein mentioned have knowledge of the construction of said improvement.

The name of the person who employed claimant to perform said labor, to furnish said materials and/or equipment and to whom he furnished said materials or rented said equipment is Don E. Johnson Construction, Inc.

The kind of labor so performed, materials so transported or furnished and equipment so rented by claimant was:

4 deducting all just credits and offsets, to-wit:



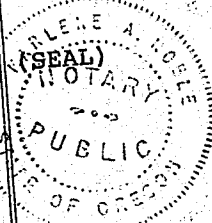
