## ASSIGNMENT OF CONTRACT

KNOW ALL MEN BY THESE PRESENTS, That the undersigned, for the consideration hereinafter stated, hereby grants, bargains, sells, assigns and sets over unto CERTIFIED MORTGAGE CO., an Oregon corporation

his heirs, successors and assigns all of the vendee's right, title and interest in and to that certain attached, unrecorded contract dated February 20., 1975, between ARTHUR C. LEAMING, Personal representative of the Estate of Oscar L. Grimes, deceased as seller, and MICHAEL D. HENRY as buyer, for the sale and purchase of the following described real estate in Klamath County, Oregon:

together with all of the right, title and interest of the undersigned in and to the real estate described therein; the undersigned hereby expressly covenants with and warrants to the assignee above named that the undersigned is the owner of the vendee's interest in the real estate described in said contract of sale and that the unpaid balance of the purchase price thereof is not more than \$2,644.77 with interest paid thereon to August 17, 1981; further, upon compliance by said assignee with the terms of said contract, the undersigned directs that conveyance of said real estate be made and delivered to the order of said assignee.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$10,000.00\*
