Lots 7, 8, 12, 13, 14, and 15, Block 10, Tract 1173, being a subdivision of Lot 1, Block 10, Lynnewood Tract 1091, in the City of Klamath Falls, Klamath County, Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, free of all encumbrances except reservations, restrictions, easements and rights-of-way of record and those apparent upon the land.
