 now decked in the dry deck area of the old Robert Dollar mill,  
 known at the present time as Gregory Timber Resources, Inc., an  
 assumed business name, north of the City of Klamath Falls,  
 Klamath County, State of Oregon for labor performed in the trans-  
 porting of said logs. Said lien is also claimed as against the  
 proceeds of any subsequent sale of said logs.

That the name of the owner or reputed owner of said  
 logs is LITTLE RIVER LUMBER PRODUCTS, Co. and that said defendant  
 employed the claimant to perform said transportation upon the  
 following terms and conditions:

Claimant was to receive \$110.00 per load for a  
 portion of said logs, \$190.00 per load for a  
 further portion of said logs, and \$325.00 per  
 load for a further portion of said logs.

and under said agreement has become entitled to the sum of \$760.00  
 being the amount claimed under this lien.
