- B. Upon default and the giving of such 15-day notice thereof, Grantor shall have the option within said 15-day period to deed the abovedescribed premises to the Beneficiary, by a form of estoppel deed in lieu of foreclosure, and beneficiary shall accept said deed and become entitled to the immediate possession of said property.

Upon default by the Grantor in the payment of said Promissory Note or in the performance of any covenant herein, and following 15 days notice without cure, the Beneficiary may declare all sums secured hereby immediately due and payable and may deliver to the Trustee a written notice of default and election to sell the property. Upon delivery of said notice of default and election to sell, the Beneficiary shall deposit with the Trustee this Deed of Trust and all promissory notes and documents evidencing expenditures secured hereby, whereupon the Trustee shall fix the time and place of sale and give notice thereof as then required by law.
