

## EXCHANGE DEED

This DEED made this 1st day of September, 1981, between the UNITED STATES of AMERICA, Grantor, acting herein by and through the Forest Service, United States Department of Agriculture, and STATE OF OREGON, acting by and through its Department of Transportation, Park and Recreation Divisions, Grantee.

WITNESSETH: That the Grantor, hereunto authorized by the Act of Congress approved March 1, 1911, as amended, (16 USC 516); the Act of March 23, 1972 (86 Stat. 99), and the Act of October 21, 1976 (43 U.S.C. 1716), the provisions of which have been complied with, for and in consideration of the conveyance to it by the Grantee of lands in the Counties of Klamath and Douglas, State of Oregon, as stated in the deed to the United States executed April 28 1981, and recorded May 6 1981 in Vol. M. 81, Page 911, Official Records of Klamath County and the sum of \$22,400.00, the receipt of which is hereby acknowledged, does hereby remise, release and quitclaim unto the Grantee all its rights, title and interest in and to the real property situated in County of Klamath, State of Oregon, described as follows:

RESERVING UNTO THE UNITED STATES OF AMERICA and its assigns all gas, oil, geothermal steam, and associated geothermal resources, subject to the Secretary of Agriculture's Rules and Regulations.

## SUBJECT TO:

1. A 125-foot wide kV power transmission line right-of-way belonging to Pacific Power and Light Company. The right-of-way was conveyed to California-Oregon Power Company (now Pacific Power and Light Company) by Bonneville Power Administration, March 26, 1954, by Contract No. 14-03-001-10387, Supplemental Agreement No. 2. (Affects Lot 1, Section 10, W $\frac{1}{2}$ NW $\frac{1}{4}$ , NW $\frac{1}{4}$ SW $\frac{1}{4}$ , Section 11, T. 34 S., R. 7 E., W.M.)
2. Treaty Rights between the United States and the Klamath Indians.

TO HAVE AND TO HOLD the above-described real property unto the Grantee, his heirs and assigns forever, together with all hereditaments and appurtenances thereunto belonging.


