AGREEMENT REGARDING OWNERSHIP AND RIGHT OF FIRST REFUSAL

WHEREAS, SIDNEY PERHAM WOODSUM, JR. and JOAN LOUISE WOODSUM, the parties hereto, are the owners of record of the following real property located in Klamath County, Oregon:

The other party shall have 22 twenty (20) days from the date of mailing of such offer in which to notify the party desiring to sell, in writing by 23 certified mail, return receipt requested, to the address from which the offer was mailed, or such other address as may be 24 specified in writing in the offer by certified mail, return receipt requested, of his or her intent to purchase the property 25 upon the same terms and conditions as those in the bona fide offer. Such notice shall entitle the other party to purchase the property 26 according to said terms. Failure to so notify the party desiring to sell within twenty (20) days shall be a rejection of the offer 27 and allow the party desiring to sell the property to the original offer or upon those terms. 28

2. In the event that either party commences legal action
29 to enforce this agreement, the prevailing party in such action
30 shall be entitled to reasonable costs and attorney fees from the other.
