IN WITNESS WHEREOF, Gulf Oil Corporation has caused these presents to be executed this 5th day of October, 1981.

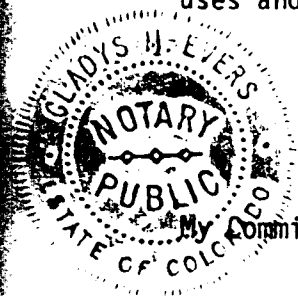
