

EASEMENT FOR WATER LINE

That, We, Leroy G. Gienger and Elaine P. Gienger, husband and wife, do hereby grant, bargain, sell and convey to the CITY OF CHILOQUIN, CHILOQUIN, OREGON, a perpetual easement for the installation, replacement, and repair of and maintenance of water lines, to be installed below the surface of the ground, together with rights of access thereto for the purposes stated, on, in and along the following described parcel of land:

Beginning at a point nine hundred thirty (930) feet north of the Southeast corner of Section thirty four (34), Township Thirty Four (34) south of Range Seven (7) East of the Willamette Meridian; thence West one Hundred (100) feet; thence North Fifty Four (54) feet; thence West Four Hundred Ten (410) feet to the Northeast corner of said parcel and the True Point of Beginning; thence West one Hundred Fifty (150) feet; thence South Thirty-Five (35) feet; thence East one Hundred Fifty (150) feet; thence North Thirty Five (35) feet to the North East Corner of said parcel and the True Point of Beginning.

Together with the right of ingress and egress over the adjacent lands of the Grantor, his successors and assigns, for the purposes of this easement.

IT IS EXPRESSLY UNDERSTOOD that this easement does not convey the right, title or interest to the surface of the soil, but only the reasonable use thereof, for the purposes here and above stated not any other rights except those expressly stated in this easement, nor to prevent the Grantors from the full use of the area for purposes not inconsistent with the easement.
