The Personal Representative filed her Final Account and the time for filing objections having passed with no objections filed, the Court finds that:

(1) All Oregon income, inheritance and personal property taxes have been paid and appropriate receipts, releases and clearances therefor have been filed herein.

(2) The Personal Representative has been compensated for her services in the estate in the amount of \$2,083.98; W. C. Schwenn has been compensated for his services in the estate in the amount of \$3,006.05, together with costs in the sum of \$3.

(3) The remainder of the estate assets is vested in the following:

(a) \$1,000.00 to ROBERT ROBERTSON, Forest Grove, OR 97116.

(b) \$1,000.00 to VALORIE HEREFORD, Aloha, OR 97005.

(c) \$1,000.00 each to JOANA AMBERS, ELAINE AMBERS, NORMA AMBERS and CAMILLE AMBERS, Klamath Falls, OR 97601 to be held in trust by Clifford Ambers Jr. in a savings and loan association.

(d) \$1,000.00 each to MICHAEL HEREFORD, Aloha, OR 97005, TODD ROBERTSON and RONALD ROBERTSON, Trail, OR 97541 to be held in trust by Robert E. Robertson in a savings and loan association.

(e) Two-thirds (2/3rds) of the residue to NORMA LAVERNE ROBERTSON, Portland, OR 97219, but subject to being reduced by the sum of \$2,000 which is the true and appraised value of the unimproved lot in Klamath Falls, Oregon.

(f) One-third (1/3rd) of the residue to CLIFFORD L. AMBERS JR., Klamath Falls, OR, but subject to being reduced by the following items: (1) Trailer, \$3,000; (2) Oldsmobile vehicle \$500; (3) promissory note made by Clifford L. Ambers Jr. in the amount of \$5,035.71, or a total reduction of \$8,535.71.

(4) Proof of mailing the notice of the time for filing objections to the Final Account has been filed herein.

IT IS HEREBY ORDERED AND DECREED:

(1) The Personal Representative is directed to make distribution of the remaining estate property to the persons and in the amounts set forth in Paragraph (3) above, in whom said property is hereby vested.

(2) The Final Account is hereby approved.
