Notice is hereby given that the undersigned (hereinafter called the "claimant") claims a lien upon certain Douglas Fir Logs, Cedar Logs, and cull logs

being about 52 loads of logs for a total of 718 logs more or less, which were cut or manufactured in Jackson County, State of Oregon, are marked thus Branded WL log storage decks of WEBCO LUMBER CO., 16024 Williams Highway, Grants Pass, Oregon 97526 for labor performed upon and assistance rendered in transporting logs

(Securing—cutting—manufacturing—handling—transporting logs or lumber)

That the name of the owner, or reputed owner of said wood products is WEBCO LUMBER COMPANY; that Clint Webb

employed claimant to perform such labor and render such assistance upon the following terms and conditions: claimant would transport logs for defendant for which claimant would be paid \$250 per load for 1 load, \$100 per load for 4 loads, \$40 per load for 7 loads, \$180 per load for 40 loads.

(State contract, if any, or reasonable value)

that said contract has been faithfully performed and fully complied with on the part of claimant who performed said labor and rendered said assistance for the period of October 16 through November 30, 1981; that said labor and assistance were so performed and rendered upon said property, between the 16th day of October, 1981, and the 20th day of November, 1981, and the rendition of said services was closed on the 20th day of November, 1981, and thirty days have not elapsed since that time; that the amount of claimant's demands for said service is \$8,010.00 plus \$15.00 as costs for the preparation of this lien notice, a total of \$8,020.00; that no part thereof has been paid, except \$none and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$8,040.00, in which amount he claims a lien upon said property.
