RELEASE

THIS RELEASE, made and executed this 9 day of December,
1981, by the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION,
Highway Division, hereinafter called "State",

WITNESSETH:

WHEREAS, State, as evidenced by that Certificate recorded on August 18, 1958, in
Volume 302, Page 229, Deed Records, acquired easement rights to use the following
described property, for stockpile purposes, to wit:

A parcel of land lying in the S $\frac{1}{4}$ S $\frac{1}{4}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 30, Township 34
South, Range 7 East, W.M., Klamath County, Oregon; the said parcel being
described as follows:

Beginning at the South quarter corner of said Section 30; thence South
87° 55' East along the South line of said Section 30, a distance of 259.9
feet to a point which is 50 feet distant Westerly from (then measured at
right angles to) the relocated center line of The Dalles-California Highway
at Engineer's Station 1524+48.4; thence North 11° 39' West parallel to and
50 feet distant Westerly from said center line, a distance of 336.0 feet;
thence North 87° 55' West 189.4 feet to a point on the North and South
center line of said Section 30; thence South 0° 28' West along said center
line of Section 30, a distance of 326.5 feet to the point of beginning,
containing 1.68 acres.

WHEREAS, State no longer needs said property for stockpile purposes; and

WHEREAS, State finds it to State's best interest to release its easement rights
in the above described property to the owner of said property.

NOW, THEREFORE, State does hereby release to the present owner of the above
described property said easement rights in the above described property.
