KNOW ALL MEN BY THESE PRESENTS, That the undersigned, for the consideration hereinafter stated, has sold and assigned and hereby does grant, bargain, sell, assign and set over unto G. Robert Lecklider and Nancy C. Lecklider, Husband and Wife,

his heirs, successors and assigns, all of the vendee's right, title and interest in and to that certain contract for the sale of real estate dated December 7, 1977, between Kenneth M. Moty and Janet Moty, husband and wife as seller and Michael P. Veatch and Carol Veatch, husband and wife,
