ASSIGNMENT OF CONTRACT

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, for the consideration hereinafter stated, has sold, assigned and hereby does grant, bargain and set over unto WALTER R.CULBERTSON and BARBARA M. CULBERTSON, or the survivor thereof, their heirs, successors and assigns all of assignor's right title and interest in and to that certain Contract of Sale dated August 2,1977 wherein Homer A. Barnes and Hazel J. Barnes are the Sellers and Luther H. Dearborn is the Buyer covering the following described real property:
