## BARGAIN AND SALE DEED

Edward Lee Campbell, hereinafter called grantor, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining, situated in the County of..... Klamath..... State of Oregon, described as follows, to-wit: Parcel 1: A portion of the NW1/4SW1/4 of section 9, Township 39 South, Range 10, E.W.M., described as follows: Beginning at a point on the North line of said NW1/4SW1/4 which lies East a distance of 104.0 feet from the Northwest corner of said NW1/4SW1/4; thence continuing along said north line East a distance of 104.0 feet to a point; thence South at right angles to said North line, a distance of 416.0 feet to a point; thence West, parallel to said North line, a distance of 416.0 feet to a point; thence North, at right angles to said North line, a distance of 104.0 feet to the point of beginning. Excepting that portion lying within the right-of-way of Pine Grove Road. Parcel 2: A portion of the NW1/4SW1/4 of Section 9, Township 39 South, Range 10, E.W.M., described as follows: Beginning at a point on the West line of said NW1/4SW1/4 which lies South a distance of 416.0 feet from the Northwest corner of said NW1/4SW1/4; thence East, parallel with the North line of said NW1/4SW1/4, a distance of 208.0 feet to a point; thence South, at right angles to said North line, a distance of 208.0 feet to a point; thence West, parallel with said North line, a distance of 209.4 feet to a point; thence North along said West line a distance of 209.4 feet, more or less, to the point of beginning; containing 1.0 acres, more or less.
