MEMORANDUM OF MODIFICATION AGREEMENT

On February 17, 1982, Equitable Savings and Loan Association, Paul D. Ferderber and Grace E. Ferderber as Borrowers and Vernon R. Powers and Randal R. Powers as Purchasers executed a Modification Agreement concerning Equitable's Loan Number 202106825, which is evidenced by a Promissory Note dated June 21, 1973 and secured by a Deed of Trust which was recorded on June 26, 1973 in Volume M-73, Page 8083, Official Records of Klamath County, Oregon, covering the real property described as:

The parties modified this loan by increasing the interest rate from 7.50% per annum to 9.50% per annum for the remaining term of the loan and by increasing the monthly principal interest payment from \$109.38 to \$123.96. The modifications were effective upon execution of the agreement.

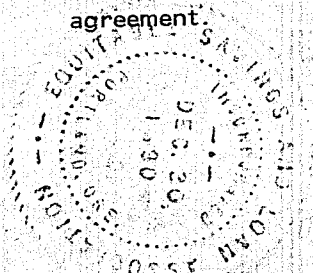
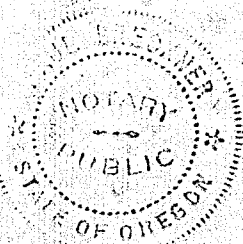
