R E S O L U T I O N

WHEREAS, FOOTHILL BOULEVARD has been proposed for construction, and

WHEREAS, the decision has been made to proceed with the acquisition of the property needed for road right-of-way, and

WHEREAS, on the 26th day of January, 1982 RICHARD K. NEWMAN and ARLA R. NEWMAN, husband and wife, conveyed to Klamath County certain property for road purposes described as follows:

A tract of land situated in the $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 35, Township 38 S., Range 9 E., W.M., Klamath County, Oregon, being a portion of that tract of land described in Deed Volume M77-867 Klamath County Deed Records, more particularly described as follows:

Beginning at the CN 1/16 corner of said Section 35, from which the N $\frac{1}{2}$ corner of said Section 35 bears N.00°16'09" E. 1341.27 feet and Engineers Station 88+90.59 bears N.00°16'09" E. 50.00 feet; thence N.89°54'13" E. 333.63 feet to the Northeast corner of the $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ of said Section 35; thence along the East line of said $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$ S. 00°16'03" W. 20.00 feet to a point 70.00 feet right of Engineers Station 92+23.78 Foothill Boulevard; thence S. 89°54'13" W. 333.63 feet to the West line of the NE $\frac{1}{4}$ of said Section 35; thence N.00°16'09" E. 20.00 feet to the point of beginning.

WHEREAS, the Board of County Commissioners of Klamath County, Oregon sitting in regular session the 12th day of March, 1982 deemed it to be in the best interest of said County to accept the described property for road purposes;

THEREFORE IT IS ORDERED AND RESOLVED that the described property conveyed to Klamath County, Oregon shall be accepted as road right-of-way.
