Modifications. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

A. INTEREST RATE AND MONTHLY PAYMENT CHANGES

The Note has an "Initial Interest Fate" of 15.14%. The Note interest rate may be increased or decreased on the 1st day of the month beginning cn September, 1983... and on that day of the month every ...12. months thereafter.
