DECREES OF FINAL DISTRIBUTION AND
ORDER APPROVING FINAL ACCOUNT

The personal representative filed his final account on November 19th, 1981, and the devisees having approved the same in writing and waived the remainder of time for filing objections thereto, the court finds that:

1. All Oregon income, inheritance and personal property taxes have been paid and appropriate receipts, releases and clearances therefor have been filed herein;

2. The personal representative is entitled to compensation from the estate in the amount of \$6,661.31 for his services as personal representative, as provided by ORS 116.173.

13 PARCEL II: The Northerly 65.4 feet of the following described
 14 tract of land, to-wit: Beginning at the intersection of the
 15 East line of the lane running North and South through
 16 the center of Section 2, Township 39 South, Range 9 E.W.M.,
 17 and the North line of the Dalles-California Highway through
 18 said center of Section; thence East along the North line of
 19 said Highway 76 feet; thence North and parallel with said
 20 lane 189.4 feet; thence West and parallel with Highway 76
 21 feet; thence South along the East line of said lane 189.4
 22 feet to the place of beginning.

23 5. Pursuant to Order of this Court dated September 2, 1981,
 24 a partial distribution of the assets of said estate in the amount
 25 of \$5,000.00 each, was made to the said DONNA PULLEY and REBECCA
 26 CANADAY.

6. That Letters of Guardianship on behalf of SEPHORA CANADAY
 and DEREK CANADAY, minors, have heretofore been issued to JERRY
 CANADAY and REBECCA CANADAY out of the Superior Court for the
 State of California, County of Alameda, a copy of which are on
 file in this proceeding.

7. The final account should be approved.

IT IS ORDERED AND DECREED:

1. The final account is approved except as it may be modified by this order;

2. The partial distribution of \$5,000.00 each to DOMNA PULLEY and REBECCA CANADAY is confirmed;

3. The personal representative is directed to pay the remaining claims and expenses of administration as set forth above;

4. The personal representative is allowed the sum of \$4,661.31 as just and reasonable compensation for his services and \$5,761.00 as attorney's fees;

5. The personal representative is directed to make distribution of the remaining estate property to the persons and in the amounts set forth in paragraph 4 above, subject, however, to said partial distribution, and said property is hereby vested in said persons in the amounts set forth.
