1. All Oregon income, inheritance and personal property taxes have been paid and appropriate receipts, releases and clearances therefor have been filed herein;
2. The personal representative is entitled to compensation from the estate in the amount of \$4,681.31 for his services as personal representative, as provided by ORS 116.173.
3. Remaining unclassified claims and expenses of administration, including reasonable attorney's fees, are:
 Expenses of administration estimated to be \$1,000
 Attorney fees in the amount of \$5,761.00
4. The remainder of the estate assets after payment of the expenses set forth above is vested in the following devisees under decedent's will:

Said bequests including, but not limited to, an undivided one-fourth interest each in and to the following real property situated in the County of Klamath, State of Oregon, and described as follows:

PARCEL I: Tract 100 of PLEASANT HOME TRACTS NO. 2 according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

PARCEL II: The Northerly 65.4 feet of the following described tract of land, to-wit: Beginning at the intersection of the East line of the lane running North and South through the center of Section 2, Township 39 South, Range 9 E.W.M., and the North line of the Dalles-California Highway through said center of Section; thence East along the North line of said Highway 76 feet; thence North and parallel with said lane 189.4 feet; thence West and parallel with Highway 76 feet; thence South along the East line of said lane 189.4 feet to the place of beginning.

5. Pursuant to Order of this Court dated September 2, 1981, a partial distribution of the assets of said estate in the amount of \$5,000.00 each, was made to the said DONNA PULLEY and REBECCA CANADAY.

6. That Letters of Guardianship on behalf of SEPHORA CANADAY and DEREK CANADAY, minors, have heretofore been issued to JERRY CANADAY and REBECCA CANADAY out of the Superior Court for the State of California, County of Alameda, a copy of which are on file in this proceeding.

7 maining claims and expenses of administration as set forth above;

8 4. The personal representative is allowed the sum of
9 \$4,661.31 as just and reasonable compensation for his services and
10 \$5,761.00 as attorney's fees;

11 5. The personal representative is directed to make distri-
12 bution of the remaining estate property to the persons and in the
13 amounts set forth in paragraph 4 above, subject, however, to said
14 partial distribution, and said property is hereby vested in said
15 persons in the amounts set forth.
