## NOTICE OF DEFAULT AND ELECTION TO SELL

THOMAS G. ALLISON AND DONNIE J. ALLISON, husband/wife, as grantor, made, executed and delivered to TRANSAMERICA TITLE INSURANCE COMPANY INC., as trustee, to secure the performance of certain obligations including the payment of the principal sum of \$ 5,200.00 in favor of WELLS FARGO REALTY SERVICES INC., a California corporation beneficiary, that certain trust deed dated June 4, 1978, and recorded AUGUST 17, 1978 in Book/Reel/Volume No. M78 at page 18161 as Document/Fee/Pite/Instrument/Microfilm 176. (Indicate which) of the mortgage records of Klamath County, Oregon, covering the following described real property situated in said county:

The undersigned hereby certifies that no assignments of the trust deed by the trustee or by the beneficiary and no appointments of a successor-trustee have been made except as recorded in the mortgage records of the county or counties in which the above described real property is situate and that the beneficiary is the owner and holder of the obligations, the performance of which is secured by said trust deed; further, that no action, suit or proceeding has been instituted to recover the debt, or any part thereof, now remaining secured by the said trust deed, or, if such action or proceeding has been instituted, such action or proceeding has been dismissed.

which are now past due, owing and delinquent. Grantor's failure just described is the default for which the foreclosure mentioned below is made.

By reason of said default, the beneficiary has declared all obligations secured by said trust deed immediately due, owing and payable, said sums being the following, to-wit: \$4,260.80 plus interest thereon from June 15, 1981 at the rate of EIGHT (8%) percent per annum until paid; and all sums expended by the beneficiary pursuant to the terms and provisions of the note and deed of trust

Notice hereby is given that the undersigned, by reason of said default, has elected and he hereby does elect to foreclose said trust deed by advertisement and sale pursuant to Oregon Revised Statutes Sections 86.705 to 86.795, and to cause to be sold at public auction to the highest bidder for cash the interest in the said described property which the grantor had, or had the power to convey, at the time of the execution by him of the trust deed, together with any interest the grantor or his successors in interest acquired after the execution of the trust deed, to satisfy the obligations secured by said trust deed and the expenses of the sale, including a reasonable charge by the trustee as provided by law, and the reasonable fees of trustee's attorneys.
