BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, That JASPER S. ROBERTS and WANDA LEE ROBERTS, husband and wife, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto AMY E. WING, husband and wife hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

The E. 1/4 SW 1/4 of Section 24, Township 32 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon, lying North of the center thread of the Williamson River.

SUBJECT, however, to the following:

1. Rights of the public in and to any portion of the herein described premises, lying within the limits of streets, roads or highways.
2. Rights of the public and of governmental bodies in and to that portion of the hereinafter described premises lying below the high water mark of the Williamson River.
3. Subject to all subsurface rights except water, to the heirs of Virgil Wilson, their heirs and assigns as set forth in that certain instrument dated September 3, 1957, recorded November 1, 1971 in Volume M71, page 11459, Microfilm Records of Klamath County, Oregon.
4. Subject to such rights as the Pacific Telephone and Telegraph Company may have under the act of March 3, 1901 as set forth in that certain instrument dated September 3, 1957, recorded November 1, 1971 in Volume M71, page 11459, Microfilm Records of Klamath County, Oregon.
5. An easement created by instrument, including the terms and provisions thereof, dated July 17, 1972; recorded January 22, 1976 in Volume M76, page 1098, Microfilm Records of Klamath County Oregon, for 60 foot roadway for ingress and egress over the Northerly boundary.
