Section 1: That Ordinance No. 210 is hereby repealed.

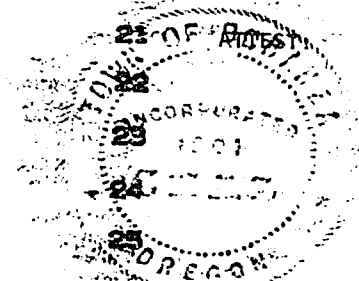
Section 2: This Ordinance being deemed necessary for the public

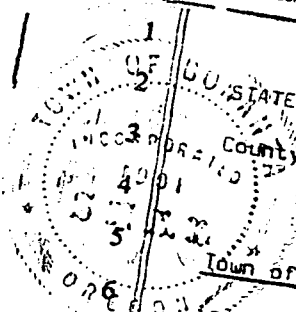
