9 WHEREAS, the Common Council of the Town of Bonanza has  
10 received a Quitclaim Deed from Ron Merman deeding the Northerly  
11 10 Feet of Lots 7, 8, 9, and 10, Block 32 to the Town to be used  
12 to increase the width of the alley located in Block 32, between  
13 Carroll Street and Sixth Street, and

14 WHEREAS, The Town of Bonanza owns Lot 6, in Block 32  
15 and feels that the Northly 10 Feet of said lot should also be  
16 dedicated to make the width of the alley uniform, now, therefore,

THE TOWN OF BONANZA DOES ORDAIN AS FOLLOWS:

17 Section 1: That the Northerly 10 feet of Lot 6, in Block  
18 32, located in the Town of Bonanza, County of Klamath, State of  
19 Oregon, owned by the Town of Bonanza be and is hereby dedicated to  
20 increase the width of the alley running from Carroll Street to  
21 Sixth Street, in Block 32.

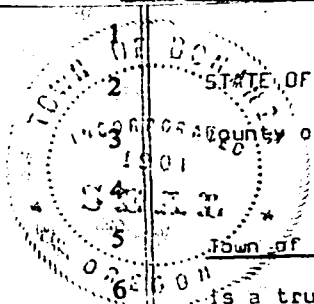
