THIS DEED made May 5, 1982, between TOM DURYEE, Sheriff of Klamath County, Oregon, hereinafter called Grantor and Rachel E. Fowler, General Delivery, Keno, Oregon 97627, hereinafter called Grantee.

In a suit in the Circuit Court of the State of Oregon for Klamath County, Oregon, between Aubrey L. Gardner and Shirley M. Gardner, husband and wife, Plaintiffs and Michael R. Fowler and Rachel E. Fowler, husband and wife, Defendants, a judgment was entered on December 24, 1980, and the Court thereafter issued a Writ of Execution and purguant thereto on February 23, 1981, all of the interest of the Defendants in the real property was sold at public auction, subject to redemption, in the manner provided by Ew, for the sum of \$12,668.63, to Aubrey L. Gardner and Shirley M. Gardner, husband and wife, the highest bidder; and after receiving from the purchaser the sum of money so bid, duly executed and delivered to the purchaser a Certificate of Sale; and filed the faturn of sale with the Court and an order confirming the sale was entered on March 20, 1981; and on July 20, 1981, the property was redeemed by Grantee (Redemptioner), Rachel E.
