

CONSENT AND SUBORDINATION AGREEMENT

WHEREAS, Weyerhaeuser Company, a Washington corporation, hereinafter called "Weyerhaeuser," has an interest in the real property hereinafter described by virtue of an easement dated the 26th day of June, 1981, and recorded the 14th day of July, 1981 in Klamath County, Oregon in Vol. M81, pages 12624-12628, and which easement traverses the following described real property situated in Klamath County, Oregon, to wit:

Government Lot 3 of Section 5, Township 34 South, Range 14 East, W.M.

WHEREAS, State of Oregon, acting by and through its Board of Forestry, hereinafter called "State," has conveyed to the United States of America, hereinafter called "Forest Service," an easement for right-of-way purposes over and across said real property located in said Section 5 by virtue of an instrument dated the 22nd day of September, 1981, and recorded the 25th day of September, 1981 in Klamath County, Oregon in Vol. M81, page 17162.

NOW THEREFORE, Weyerhaeuser consents to the above-mentioned conveyance from State to Forest Service, and subordinates its interest in the real property hereinbefore described to the rights of Forest Service in and to said real property by virtue of the above-mentioned instrument.
