QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That GEORGE P. WU and IDA L. WU, Husband & Wife, formerly stockholders of WU RANCHES, INC., hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and quitclaim unto ROBERT G. WU as Trustee for the following beneficiaries, ROSALIE G. WU and SUZIE A. WU, minor children, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any-wise appertaining, situated in the County of KLAMATH, State of Oregon, described as follows, to-wit:

A tract of land situated in Lot 1, Section 19, T 38 S, R 11 EWM, Klamath County, Oregon, more particularly described as follows: Beginning at a 5/8 inch iron pin marking the northwest corner of said Section 19; thence S 89°32' E along the north line of said Section 19 a distance of 1031.24 feet to the True Point of Beginning of this description; thence S 0°28' W at right angles to the north line of said Section 19 a distance of 30.00 feet to a 1/2 inch iron pin on the south right-of-way line of the County Road; thence continuing S 0°28' W a distance of 260.40 feet to a 1/2 inch iron pin; thence South 89°32' E parallel with the north line of said Section 19 a distance of 150.00 feet to a 1/2 inch iron pin; thence N 0°28' E a distance of 260.40 feet to a 1/2 inch iron pin on the south line of said County Road; thence continuing N 0°28' East a distance of 30.00 feet to the north line of said Section 19; thence N 89°32' W along the north line of said Section 19 a distance of 150.00 feet to the True Point of Beginning.
