The true and actual consideration paid for this transfer, which is stated in terms of dollars, is \$1,495.00 cash.

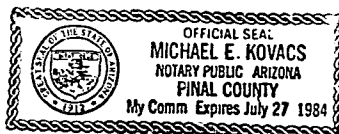
