(1) A person who forecloses a lien created by sections 1 to 5 of this Act by sale shall file a statement of account verified by his oath with the recording officer of the county in which the sale took place when:
(a) The chattel sold at the foreclosure sale has a fair market value of \$250 or more;
(b) The chattel sold at the foreclosure sale is an animal bearing a brand or other mark recorded with the State Department of Agriculture under ORS chapter 601.
(3) A person filing a statement of account under this section shall send a copy of the statement to the owner of the chattel sold at the foreclosure sale by registered or certified mail sent to him at his last known address. If the chattel sold at a foreclosure sale is an animal bearing a brand or other mark recorded with the State Department of Agriculture under ORS chapter 601, a person filing a statement of account under this section shall send a copy of the statement to the State Department of Agriculture.

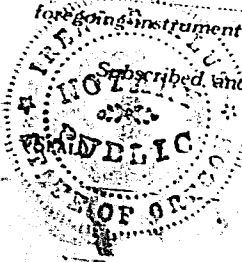
