DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated October 30, 19 79, executed and delivered by RICHARD P. BRIGHT and JESSELYN KAY BRIGHT, his wife, as grantor and recorded on October 31, 19 79, in the Mortgage Records of Klamath County, Oregon, in book M 79 at page 25691, conveying real property situated in said county described as follows:

The West one-half of the following property in the County of Klamath, State of Oregon:

Beginning at a point which lies North 1°14' West a distance of 680.3 feet and South 89°26' West a distance of 330.0 feet from the iron pin which marks the section corner common to Sections 2, 3, 10 and 11, Township 39 South, Range 9 East of the Willamette Meridian and running thence: Continuing South 89°26' West a distance of 100 feet to an iron pin; thence North 1°14' West a distance of 144.2 feet to an iron pin; thence North 89°24' East a distance of 100 feet to an iron pin; thence South 1°14' East, a distance of 144.2 feet, more or less, to the point of beginning, being in the S½S½N½SE½SE½ of Section 3, Township 39 South, Range 9 East of the Willamette Meridian,

having received from the beneficiary under said trust deed a written request to reconvey, reciting that the obligation secured by said trust deed has been fully paid and performed, hereby does grant, bargain, sell and convey, but without any covenant or warranty, express or implied, to the person or persons legally entitled thereto, all of the estate held by the undersigned in and to said described premises by virtue of said trust deed.
