NOTICE HEREBY IS GIVEN that FLETCHER CO. (hereinafter called claimant) claims a lien upon one International Harvester Corporation truck Model COF4070, Serial Number D2327DYB14526 with Motor Number 8V-92T and bearing Oregon License Number T 423188 for labor performed and materials furnished in the repair of the above described chattels in Klamath County, Oregon; said labor, services and materials are described as follows:
