Notice is hereby given that the undersigned (hereinafter called the "claimant") claims a lien upon  
1653.845 tons Lodgepole Pine Logs

being about more or less,  
which were obtained, handled, manufactured and/or transported in Klamath County,  
State of Oregon, are marked thus Unmarked and are now lying in  
Cold deck at A-1 Pine, Chemult, Klamath County, Oregon,  
for labor performed upon and assistance rendered in  
transporting wood products.  
(Obtaining—manufacturing—handling—transporting timbers or wood products)

The name of the owner of the above described timber and/or wood products is A-1 Pine  
for whose benefit said labor was performed and assistance rendered. The  
following is a description of the said labor performed and the said assistance rendered at the request of said owner:  
Transported 50 loads of logs (1653.845 tons) from logging operation  
at Mathis Ranch near Chemult, Oregon, to A-1 Pine, Chemult, Oregon,  
and loaded 15 of said loads of logs.

The close of the furnishing of said labor assistance was July 14, 1982; 60 days have not  
elapsed since the date just mentioned.

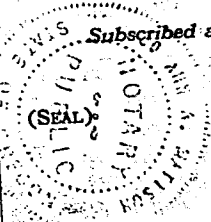

The foregoing Logger's and Woodworker's lien is authorized by Section 17 of Chapter 648, Oregon Laws 1975; Section 21 of said chapter provides in part:

"(1) A person claiming a lien created by sections 16 to 19 of this Act shall file a written notice of claim of lien with the recording officer of the county in which the lien debtor resides, or, if the lien debtor is a business, the county in which the lien debtor has its principal place of business not later than 60 days after the close of the furnishing of the labor, services or materials. \* \* \*"

Section 22 and 23 of said Chapter 648 provide:

"SECTION 22. The recording officer of the county shall record the notices filed under section 21 of this Act in a book kept for that purpose and called index of liens upon chattels."

"SECTION 23. When a lien claimant files a notice of claim of lien as required by section 21 of this Act, he shall send forthwith a copy of the notice to the owner of the chattel to be charged with the lien by registered or certified mail sent to him at his last-known address."
