LOGGER'S AND WOODWORKER'S LIEN

Notice is hereby given that the undersigned (hereinafter called the "claimant") claims a lien upon all lodge-pole pine logs, merchantable timber, including cross ties, chips and/or components of said logs delivered to, or processed by the lien debtor, and delivered to one or more processors including Publishers Paper Company and Crown-Zellerbach Company, Portland, Oregon

being about 5,200 Tons which were obtained, handled, manufactured and/or transported in Klamath County, State of Oregon, are marked thus and are now lying in storage or process, with Publishers Paper Company and Crown-Zellerbach Company

for labor performed upon and assistance rendered in obtaining, handling and transporting timbers and chips (Obtaining—manufacturing—handling—transporting timbers or wood products)

The name of the owner of the above described timber and/or wood products is A-1 Pine Products, Inc., for whose benefit said labor was performed and assistance rendered. The following is a description of the said labor performed and the said assistance rendered at the request of said owner:

In cutting, limbing, trimming, loading, and transporting timber and wood products to lien debtors mill, also for the stumpage costs associated with purchase of said products, and use of claimants equipment.

The close of the furnishing of said labor assistance was July 14, 1982; 60 days have not elapsed since the date just mentioned. The following is a true statement of claimant's demand for which this lien is claimed:



The foregoing Logger's and Woodworker's lien is authorized by Section 17 of Chapter 648, Oregon Laws 1975; Section 21 of said chapter provides in part:

"(1) A person claiming a lien created by sections 16 to 19 of this Act shall file a written notice of claim of lien with the recording officer of the county in which the lien debtor resides, or, if the lien debtor is a business, the county in which the lien debtor has its principal place of business not later than 60 days after the close of the furnishing of the labor, services or materials. \* \* \*

Section 22 and 23 of said Chapter 648 provide:

"SECTION 22. The recording officer of the county shall record the notices filed under section 21 of this Act in a book kept for that purpose and called index of liens upon chattels."

"SECTION 23. When a lien claimant files a notice of claim of lien as required by section 21 of this Act, he shall send forthwith a copy of the notice to the owner of the chattel to be charged with the lien by registered or certified mail sent to him at his last-known address."
