KNOW ALL MEN BY THESE PRESENTS, That

PAUL A. TAYLOR AND MARGARET R. TAYLOR

hereinafter called the grantor, for the consideration, hereinafter stated, to grantor paid by GARY YOCES as to an undivided $\frac{1}{2}$ interest, JAMES PHILIP FIORE as to an undivided $\frac{1}{2}$ interest the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or pertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 10 in Block 30 of 4th Addition to Nimrod River Park, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Subject to reservations, restrictions, rights of way of record and those apparent upon the land; Taxes for 1982-83 which are now a lien but, not yet due and payable.

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$2,250.00.

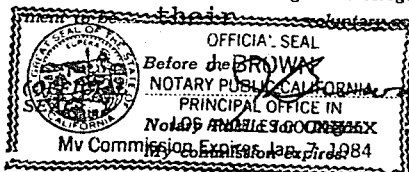
