WHEREAS, Owners have requested that their access rights opposite said Station 295+00 be terminated and that there be substituted therefor access rights to and from the Easterly and Westerly sides of said highway opposite Engineer's Station 295+00 unrestricted as to use; and

NOW, THEREFORE, THIS INDENTURE WITNESSETH that for and in consideration of the grant hereinafter made by State, OWNERS do hereby transfer and relinquish unto State, its successors and assigns, their access rights to and from the Easterly and Westerly sides of the Willamette Highway opposite said Station 295+00 reserved in said deed recorded on January 5, 1956. Owners represent and warrant that no one, other than Owners, is using or entitled to use the access rights herein relinquished. STATE, in consideration of the relinquishment and warranties herein made, does hereby grant and convey unto OWNERS, their heirs and assigns, access rights to and from the Easterly and Westerly sides of said highway, opposite said Station 296-53 in a width of 35 feet and unrestricted as to use, the aforementioned contract purchasers' access rights being limited to the access which abuts their respective properties.

IT IS UNDERSTOOD that nothing contained herein shall be construed as a finding of compliance with the Statewide planning goals or the acknowledged comprehensive plan. It shall be the Owners' responsibility to obtain any necessary land use approval from the affected local government including, where applicable, a determination of the compliance with the Statewide planning goals and approval of the partitioning of the property to which the access rights herein granted are appurtenant.
