NOTICE IS HEREBY GIVEN That DORIS SMITH, dba DORIS SMITH LOGGING, claims a lien upon Firewood cut from lodge pole pine, being approximately 200 cords, more or less, which were cut in Klamath County, State of Oregon, and are unmarked, but are now piled and lying in Sections 30 or 31, Township 36 S., R. 12 East, W.M., approximately 30 to 150 feet from Highway 66 for labor performed upon and assistance rendered in furnishing a 1968 Timber Jack Skidder to skid said firewood; that said lien is also claimed against the proceeds of any subsequent sale of said firewood;

That the name of the owner or reputed owner of said firewood is STEVE ARMANTROUT; that Armantrout leased said Skidder to perform such labor and render such assistance upon the following terms and conditions: \$250.00 per week and to maintain said Skidder in good condition and mechanically sound; that said contract has been faithfully performed and fully complied with by said DORIS SMITH, dba DORIS SMITH LOGGING; and that said labor and assistance were so performed and rendered upon said firewood between the 21st day of May, 1982, and the 7th day of August, 1982, and the rendition of said services was closed on

1 the 7th day of August, 1982, and sixty days have not elapsed
 2 since that time; that the amount of Claimant's demands for
 3 said service is Four Thousand One Hundred Eight and No/100 Dol-
 4 lars; that no part thereof has been paid, except Seven Hundred
 5 Fifty and No/100 Dollars; and there is now due and remaining
 6 unpaid thereon, after deducting all just credits and offsets,
 7 the sum of Three Thousand Three Hundred Fifty-eight and No/100
 8 Dollars, in which amount a lien is claimed upon said property.
