## AGREEMENT ASSIGNING PARTNERSHIP INTEREST

This Agreement is entered into the day and year hereinafter set forth by and between DANNY O'NEILL residing in Klamath Falls, Oregon and JESSE W. JACK residing in San Jose, California with reference to the following facts:

- 3. It is now the desire of DANNY O'NEILL and JESSE W. JACK to resolve their differences.

NOW, THEREFORE, in consideration of the mutual covenants and conditions hereinafter set forth DANNY O'NEILL and JESSE W. JACK agree as follows:

1. JESSE W. JACK will pay to DANNY O'NEILL the sum of TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00) cash upon execution of this Agreement, a dismissal with prejudice of the above-described action, an assignment of the contract of purchase for the WINEMA MOTOR HOTEL to JESSE W. JACK and execution of any and all documents necessary to transfer any and all interest

- 2. JESSE W. JACK will indemnify, defend and hold harmless DANNY O'NEILL against any and all claims, liabilities, loss, costs, damages, fees of attorneys and other expenses against DANNY O'NEILL which DENNY O'NEILL incurs or has incurred as a result of his being a partner in M.J.B., LTD., a California Limited Partnership doing business in Klamath Falls, Oregon, as the WINEMA MOTOR HOTEL, or any matters, past, present or future, arising out of the operation of the WINEMA MOTOR HOTEL AND RESTAURANT.
  - 3. The effective date of this agreement is January 1, 1982.
- 4. Insofar as DANNY O'NEILL and JESSE W. JACK are concerned this Agreement supercedes the M.J.B., LTD., Limited Partnership Agreement dated November 29, 1979.
- 5. This agreement, the release, the assignment of the contract for the purchase of the WINEMA MOTOR HOTEL contains the only agreements between DANNY O'NEILL and JESSE W. JACK with respect to the matters covered by these agreements and no other agreements, statements or promises made by either party not contained herein shall be binding or valid.
- 6. This Agreement shall be binding upon and inure to the benefit of the heirs, executors, administrators, successors and assigns of the respective parties hereto.
- 7. If any legal action is necessary to enforce the terms of this Agreement, the prevailing party shall be entitled to reasonable attorney's fees in addition to any other relief



to which he may be entitled. This Agreement is executed on the 15th day of July, 1982 at Klamath Falls, Oregon.
