Frank R. Baddeley and Patsy R. Baddeley, as Grantors, made, executed and delivered to Transamerica Insurance Co., as Trustee, to secure the performance of certain obligations including the payment of the principal sum of \$1,869.86 in favor of Wells Fargo Realty Services, Inc., Trustee Under Trust 7219, as beneficiary, that certain trust deed dated February 14, 1979, and recorded March 15, 1979, in Book M79, at Page 5897, of the Mortgage Records of Klamath County, Oregon, covering the following described real property situated in said county:
