The East half of the West half of the Northeast quarter of Government Lot 4, Section 31, Township 26 South, Range 16 East of the Willamette Meridian. RESERVING THEREFROM an easement of 30 feet along all boundaries for public highway for use in common with others, with power to dedicate, and EXCEPTING THEREFROM all petroleum, oil, minerals and products derived therefrom, within or underlying said land or that may be produced therefrom and all rights thereto.
