The undersigned hereby certifies that no assignments of the trust deed by the trustee or by the beneficiary and no appointments of a successor-trustee have been made except as recorded in the mortgage records of the county or counties in which the above described real property is situate; further, that no action, suit or proceeding has been instituted to recover the debt, or any part thereof, now remaining secured by the said trust deed, or, if such action or proceeding has been instituted, such action or proceeding has been dismissed.

There is a default by the grantor or other person owing an obligation, the performance of which is secured by said trust deed, or by their successor in interest, with respect to provisions therein which authorize sale in the event of default of such provision; the default for which foreclosure is made is grantor's failure to pay when due the following sums: Monthly installments in the amount of \$114.75 each which were due and payable on February 28; March 30, April 30, May 30, June 30, July 30 and August 30, 1982; together with real-property taxes for the year 1981-82 in the amount of \$259.15, plus interest.

By reason of said default, the beneficiary has declared all obligations secured by said trust deed immediately due and payable, said sums being the following, to-wit: Principal balance of \$5,059.97 plus interest thereon at the rate of 12% per annum from January 30, 1982, until paid; together with the real property taxes and interest set forth above.

DESCRIPTION

A tract of land situate in the SW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 34, Township 35 South, Range 7 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows:
