## TERMINATION OF EASEMENT

## PARCEL 1:

Beginning at a point on the West line of Riverview Subdivision which lies South 0° 18' East (Note this bearing on Riverview shows South 0° 15' East) along the West line of Riverview a distance of 572 feet from the iron pin which marks the Northeast corner of the SwkSWk of Section 5, Township 39 South, Range 9 East of the Willamette Meridian and running thence; continuing South 0° 18' East along the West line of Riverview a distance of 533.2 feet to a point, more or less, to the intersection of an extension Easterly of the North line of parcel deeded to S. W. Percy, Trustee, by Deed recorded in Volume 140 of Deeds, page 341, Deed Records of Klamath County, Oregon; thence West along said North line of S.W. Percy, Trustee property a distance of 200 feet to a point; thence North 0° 18' West parallel to the West line of Riverview a distance of 530.24 feet to a point on the South line of a 60 foot road easement; thence North 89°42' East along the South line of said road easements a distance of 200 feet, more or less to the point of beginning, said tract in the SWkSWk of Section 5, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, less any portion thereof contained in existing roadways.
