ASSIGNMENT OF TRUST DEED BY BENEFICIARY OR HIS SUCCESSOR

FOR VALUE RECEIVED, the undersigned who is the beneficiary or his successor in interest under that certain trust deed dated April 1, 1979, executed and delivered by THEODORE B. CASE and CLIFFORD HONEYCUTT, grantor, to TRANSAMERICA TITLE INSURANCE COMPANY, trustee, in which CHARLES M. SANTO and MARIETTA H. SANTO, husband & wife is the beneficiary, recorded on April 10, 1979, in book/~~reel~~/volume No. M 79 on page 7867 or as fee/file/instrument/microfilm/reception No. 65264 (indicate which) of the Mortgage Records of Klamath County, Oregon, and conveying real property in said county described as follows:

A portion of Tract 75 of ENTERPRISE TRACTS, in the County of Klamath, State of Oregon.

Beginning at a point which is 40 feet Southerly along the Easterly line of Martin Street, if extended, from the Northeast corner of Martin Street and Shasta Way; thence Easterly and parallel with Shasta Way 150 feet to the true point of beginning of this description; thence Southerly and parallel with Martin Street, if extended, one hundred (100) feet; thence Easterly and parallel with Shasta Way 100 feet; thence Northerly and parallel with Martin Street, if extended, 100 feet; thence Westerly and parallel with Shasta Way 100 feet to the point of beginning.

hereby grants, assigns, transfers and sets over to PACIFIC WEST MORTGAGE CO., an Oregon corporation, hereinafter called assignee, and assignee's heirs, personal representatives, successors and assigns, all his beneficial interest in and under said trust deed, together with the notes, moneys and obligations therein described or referred to, with the interest thereon, and all rights and benefits whatsoever accrued or to accrue under said trust deed.

The undersigned hereby covenants to and with said assignee that the undersigned is the beneficiary or his successor in interest under said trust deed and is the owner and holder of the beneficial interest therein; that he has good right to sell, transfer and assign the same, and the note or other obligation secured thereby, and that there is now unpaid on the obligations secured by said trust deed the sum of not less than \$13,640.13 with interest thereon from October 5, 1982.

In construing this instrument and whenever the context hereof so requires, the masculine gender includes the feminine and the neuter and the singular includes the plural.
