Klamath County Planning Findings of Fact and Order

7 This request is for a Conditional Use Permit under Klamath County Ordinance 48 to create a non-farm parcel on land classified 8 as agricultural. The Planning Commission reviewed the request 9 at a hearing on August 24, 1982 and recommended approval. The 10 application was reviewed by the Board of County Commissioners on 11 October 4, 1982. Based on the record of the hearing below, the 12 Board of County Commissioners makes the following findings of 13 fact and conclusions of law: 14

FINDINGS OF FACT:

16 1. The property in question is forty acres in size and 17 consists of the NE 1/4, NE 1/4, of Section 31, Township 37, Range 18 11.

There are two mobile homes on the property.
 Applicant wishes to sell a five-acre parcel which
 includes one of the mobile homes.

4. The property is adjacent to the Yonna Woods Subdivision
and to other parcels of ten to forty acres.

5. The property is predominantly SCS Class IV soils.

25 6. Applicant has stated that he raises berries, has a
26 fifty tree apple orchard and has three acres of permanent pasture.
27 7. None of the agricultural uses are on the proposed
28 five-acre parcel.

CONCLUSIONS OF LAW: 14901 2 1. This land is compatible with farming uses and is consistent with the intent and purpose of the agricultural land 3 use policies. 4 5 2. Does not interfere seriously with accepted farming 6 practices. 7 3. Does not materially alter the stability of the overall land use pattern of the area. 8 9 4. Is situated on generally unsuitable land for the production of farm crops and livestock. 10 11 5.
